We only have 4 ISHSA approved shows (five if you count Fall Double Point as 2 shows) left before it ends. It seems like it barely started. If you wish to qualify for any year end awards, please make sure you get to at least 5 shows; unless you are a driver that requirement is only 4 shows. It has been an interesting year for sure. With our Fall Double Point show, we are changing things up a bit. This year the show will be held at High Desert Station in Star, ID. This is in an effort to keep cost low for our club as the Fall Double Point show typically has less exhibitors. Please bare with us as this will be our first time at this new venue so we will have to work the kinks out as we go. The facility offers a limited number of RV spots and approximately 80 Noble Outfitters matted stalls. We will do our best to accommodate all of our exhibitors. At the show, show management will do our best to make sure announcements are heard and announced often but it is ultimately the exhibitors responsibility to know where we are in the show and when their class is to be held. At the conclusion of the show, we ask that everyone cleans their stalls out as the club is charged \$50 per hour on clean up, and that can add up to a lot of hours. This includes the grounds. We ask that everyone do their part to keep things tidy. This year we have also added mustang only classes and a sidesaddle class! We are really trying to make sure we have something for everyone. If you are available, we will need volunteers to help set trail Saturday night and take it down at the completion of trail Sunday. The more help we have the faster and smoother the show will run. 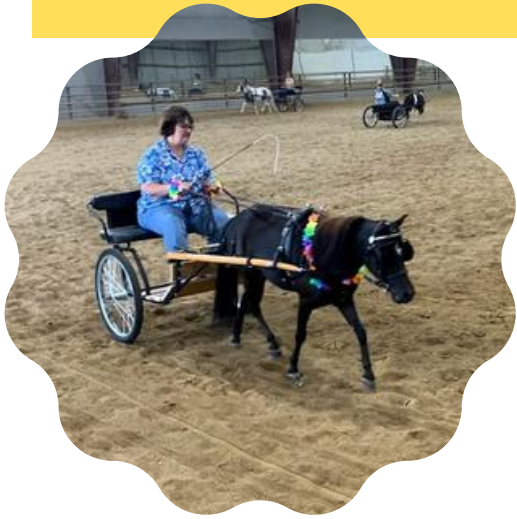

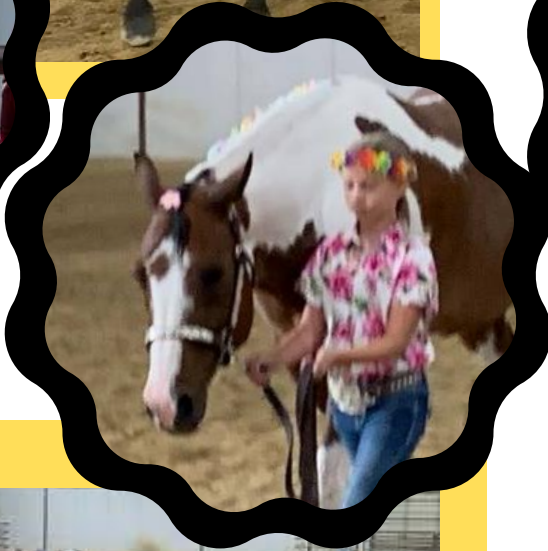
